

RISK DISCLOSURE

Headquartered in Athens, Greece our services extend to retail and institutional clients. With solid experience in the financial markets and more specifically in virtual assets, we strive to continually build on an already solid foundation.

This Notice cannot and does not disclose or explain all the risks associated with the Company's services and products. You should completely acknowledge and accept that, regardless of any information which may be offered by the Company, the value of any investment in virtual assets may fluctuate downwards or upwards and it is even likely that the investment may become of no value. The fluctuations may result to partial or even whole loss of your initial investment capital.

The Client recognizes and accepts that there may be other risks which are not covered in this section.

Specific Risks

Regulatory and Legal Risks

Potential changes in laws and regulations affecting the investment sector and/or a specifically the virtual assets, can have unforeseeable and material effects to your investment. Risk involved with regulatory or legal amendments and/or changes are unpredictable and may vary depending on the market and region.

Past Performance

Information of previous performances of virtual assets or portfolio management results do not guarantee its current and/or future performances. Volatility
